TexasFest Market Fair VENDOR RULES

Event Date: April 12-14, 2024

Deadline to register as a Vendor: March 29, 2024

1. All Food Vendor spaces will rent for a flat fee of \$500.00 per booth. Call the above numbers for details. Upon leaving Saturday evening Vendor shall remove and properly dispose of all rubbish, trash and discarded materials, including food and grease.
2. Vendor is responsible for bringing appropriate containers for disposal and removal of such disposables. ALL GREASE MUST BE PROPERLY DISCARDED AND REMOVED FROM THE FESTIVAL SITE BY THE VENDOR AND INTO THE FESTIVAL'S DUMPSTER.
3. Priority in location of leased space shall be given to those vendors in their respective area in the order that they return signed contracts with payment.
4. Food Vendors can begin setting up at 7 a.m. Vendors are asked to remove all supplies by 11 p.m.
5. Although there will be Police and Security patrolling the area during the Celebration, the Texas Independence Day Celebration Committee assumes no responsibility for the security of the Vendor's property and the Vendor agrees to hold the above parties harmless.
6. Vendors will be responsible for providing their own extension cords (we recommend 100 foot cords) canopy, lights, tables, chairs, etc. Participants using cooking equipment (open fire, frying, baking, etc) are required to have a 2.5 to 51b ABC fire extinguisher. Vendors are subject to inspection by the City's Code Enforcement/Fire Department and we hold no responsible if you are closed down due to violations.
7. Vendors shall have at least one person running the booth at all times. No children in the booth area and no more than 3 adults to a booth.
8. Must provide your own power source.
9. Booths may not be rented or sublet to any other person other than the name on the contract. Each Vendor must provide with this contract and copies of all necessary licenses / permits including but not limited to the following: A copy of the signed rental contract, Sales Tax Permits will be required from organization or individuals that cannot document their exemption from State Sales Tax. For organizations that are exempt, you must display your sales tax exemption Certificate.
10. **No Refunds for Closed Booths.**
11. Vendor must supply tables, lights and other such necessities.
12. **Absolutely NO distribution of FREE DRINKS or sales of beverages of any type. The Happy Birthday TexasFest Committee will have exclusive selling privileges to the sale of soft drinks, bottled water, coffee and hot chocolate. Any sales of drinks could result in the closure of your booth.**
